Civil Establishment (Rodrigues Regional Assembly) (Amendment) Order 2005

THE CIVIL ESTABLISMENT ACT

Order made by the President under Section 74 of the Constitution and Section 3 of the Civil Establishment Act.

- This Order may be cited as the Civil Establishment (Rodrigues Regional Assembly) (Amendment) Order 2005.
- 2. In this Order -

"principal Order" means the Civil Establishment (Rodrigues Regional Assembly) Order 2004.

- 3. The Third Schedule to the principal Order is amended-
 - (a) by deleting the offices specified in the first Schedule to this Order;
 - (b) under the sub-heading "CHIEF COMMISSIONER'S OFFICE" under the sub-heading "FORESTRY", in respect of the office of "Forest Guard", by deleting the salary code "19 61 41" and replacing it by the salary code"19 16 41";
 - (c) by deleting the sub-heading "COMMISSION FOR ARTS AND CULTURE, WOMEN'S AFFAIRS, FAMILY WELFARE, CHILD DEVELOPMENT AND COMMUNITY DEVELOPMENT" and replacing it by the sub-heading "COMMISSION FOR ARTS AND CULTURE, WOMEN'S AFFAIRS, FAMILY WELFARE AND CHILD DEVELOPMENT, COMMUNITY DEVELOPMENT AND LIBRARY SERVICES";
 - (d) by deleting the sub-heading "COMMUNITY DEVELOPMENT" and replacing it by the sub-heading "COMMUNITY DEVELOPMENT AND POVERTY ALLEVIATION";
 - (e) by inserting tile new sub-heading 'CULTURAL AND LEISURE CENTRES" immediately after the entries appearing under the new sub-heading "COMMUNITY DEVELOPMENT AND POVERTY ALLEVIATION";
 - (f) (i) by deleting the sub-heading "COMMISSION FOR EDUCATION, EMPLOYMENT AND INFORMATION TECHNOLOGY" and replacing it by the sub-heading "COMMISSION FOR EDUCATION, EMPLOYMENT, INFORMATION TECHNOLOGY AND TELECOMMUNICATON,

MUSEUMS, ARCHIVES, HISTORICAL SITES AND BUILDINGS AND VOCATIONAL TRAINING";

- (ii) under the sub-heading "EDUCATION", in respect of the office of "School Clerk", by deleting the salary code "18 17 41" and replacing it by salary code "08 17 41";
- (g) under the sub-heading "COMMISSION FOR YOUTH AND SPORTS, CONSUMER PROTECTION, TRADE, COMMERCE AND LICENCING AND HANDICRAFT, by deleting the sub-heading "HANDICRAFT: and the following entry appearing under it -

Industrial Analyst 1/317 1 02 43 63

- (h) under the sub-heading "COMMISSION FOR SOCIAL SECURITY, LABOUR AND INDUSTRIAL RELATIONS" under the subheading "INDUSTRIAL RELATIONS", in respect of the office of "Labour and Industrial Relations Officer", by deleting tile salary code "18 20 48" and replacing it by salary code" 18 24 48";
- by varying the number of posts in respect of the offices specified in the first column of Part I of the Second Schedule to this Order in the manner specified in the third column of that Schedule;
- (j) by inserting in their appropriate places the offices specified in Part II of the Second Schedule to this Order.
- 4. The offices specified in the first column and tile number of posts specified in tile second column of the Third Schedule to this Order shall be transferred from the Commission specified in the third column to that specified in the fourth column of that Schedule.
- 5. The Fourth Schedule to the principal Order is amended -
 - (a) by inserting in their appropriate order the salary codes and the corresponding emoluments specified in the Fourth Schedule to this Order;
 - (b) by deleting the existing salary scale in respect of tile salary code" 23 46 57" and replacing it by the following salary scale -

23 46 57 15500 x 500 - 17000 x 600 - 20000 x 800 - 22400

6. (1) Subject to the other provisions of this paragraph, the amendments made to this Order shall be deemed to have come into operation on 1 July 2005.

- (2) Paragraph 3 (a) shall come into operation on the date on which the present holder of an office specified in the first column of the First Schedule to this Order vacates that Office.
- (3) Paragraph 3 (i) shall, in so far as it operates a reduction in the number of offices specified in the first column of Part I of the second Schedule to this Order, come into operation on the date the holders of those offices vacate their respective offices.
- (4) Paragraphs 3 (i) and (j) shall, so far as it operates an increase in the number of offices specified in the first column of Part I of the Second Schedule to this Order or the creation of new offices specified in Part II of that Schedule-
 - (a) where a date is specified in the last column of that Schedule, come into operation on the date so specified;
 - (b) where no date is specified, be deemed to have come into operation on 1 July 2005.
