

**Rodrigues Consumer Protection (Control of Price of Taxable and Non-Taxable Goods) (Amendment
No. 20) Regulations 2004**

THE CONSUMER PROTECTION (PRICE AND SUPPLIES CONTROL) ACT

**Regulations made by the Minister under sections 3 and 35 of the Consumer Protection (Price and Supplies
Control) Act**

1. These regulations may be cited as the **Rodrigues Consumer Protection (Control of Price of Taxable and Non-Taxable Goods) (Amendment No. 20) Regulations 2004**.

2. In these regulations -

"principal regulations" means the Rodrigues Consumer Protection (Control of Price of Taxable and Non., Taxable Goods) Regulations 1998.
