## THE RODRIGUES REGIONAL ASSEMBLY ACT 2001

## Regulations made by the Rodrigues Regional Assembly under section 26(3)(b)(l) and 31 of the Rodrigues Regional Assembly Act 2001

1. These regulations may be cited as the **Rodrigues Regional Assembly (Licences) Regulations 2002**.

2. In these regulations -

"Act" means tile Rodrigues Regional Assembly Act 2001;

"Assembly" means the Rodrigues Regional Assembly;

"authorised officer" means an officer of the Rodrigues Regional Assembly;

"classified trade" means any trade or business specified in the Schedule to the trade and Industries Classification Act.

- Every person who requires a licence for the purposes of section 26(3)(b)(i) of the Act shall submit his application to the Assembly in the form set out in the First Schedule to the Trade and Industries Classification (Licences and Amendment of Schedule) Regulations 1993.
- 4. No licence shall be issued in respect of a classified trade unless favourable recommendations have been obtained from the authorities concerned.
- 5. The Assembly may, upon receipt of favourable recommendations, issue a licence which shall be in the form set out in the Second Schedule to the trade and Industries Classification (Licences and Amendment of Schedule) Regulations 1993.

6. For the purposes of section 26(3)(b)(i) of the Act, the fees payable for the activities specified in the Eighth Schedule to the Local Government Act and also specified in the first column of the Schedule to these regulations shall be as specified in the second column of the Schedule to these regulations.

7. No licence issued under these regulations shall be transferred, assigned or sublet.

- 8. Where a licensee dies, his widow, heirs or representative, as the case may be, may with the written consent of the Assembly, carry on his business, either personally or by an agent approved by the Assembly, for a period of 6 months from the date of his demise, and that person shall comply with these regulations.
- 9. Any licensee who loses his licence may, on satisfactory accounting to the Assembly for such loss, obtain a duplicate licence on payment of a fee of 50 rupees.
- 10. Any fees payable under tile Schedule in respect of any financial year shall become due as from 1 July of that year and may be paid in 2 equal instalments, the first to be on or before 31 July of that year and the second instalment on or before 31 January of the following year.

11. A surcharge of 50 percent shall be leviable on any amount unpaid as at 31 January.

- 12. (1) Every licensee shall affix the licence in a conspicuous place on the premises where the profession, trade or activity is carried out.
  - (2) Every licensee shall, at any time and in such manner as the Assembly shall direct, produce the licence to an authorised officer, affix the licence in a conspicuous place on the premises where the profession, trade or activity is carried out.
- 13. (1) Any licensee who intends to cease carrying on business on or before the date of expiry of the period for which appropriate fees, dues and charges have been paid under regulation 6, shall give notice of his intention to do so on 2 successive occasions in the *Gazette* and in 2 local weekly newspapers.

- (2) The second notice shall be published not less than 8 days before the date of the intended cessation of business.
- 14. Any licensee who -
  - (a) (a) contravenes regulation 12;
  - *(b) (b)* refuses or neglects to produce his licence on demand by an authorised officer.
  - (c) (c) obstructs, molests, insults or hinders any authorised officer who is acting in the performance of his duties; or
  - (d) (d) contravenes any condition of his licence,

shall commit an offence and shall, on conviction, be liable to a fine not exceeding 500 rupees.

15. Any person who, in connection with an application for a licence, makes any statement which he knows, or ought to have known, to be false or misleading in any material particular shall submit an offence and shall, on conviction, be liable to a fine not exceeding 2,000 rupees.
